Needs Assessment

What is it?

- A process of collecting information about the needs of people with HIV (PWH) and those not living with HIV but who may benefit from support
- Steps involve gathering data from multiple sources on:
 - STI/HIV testing
 - PrEP and PEP utilization
 - Number of new and overall HIV cases
 - Needs of PWH
 - Current available resources (Ryan White HIV/AIDS Program and other)
- This information is then analyzed to identify what services are needed and by which groups of PWH



Expectations

- As the Recipient, HAHSTA is required to participate in the statewide comprehensive statement of need (Needs Assessment).
- All funded providers are also required to participate.

OUTREACH/ recruitment

- We will work with providers on the best options for their site. Some of these include:
 - Share a QR code with customers that links to the Needs Assessment survey
 - Provide surveys and space/privacy to let customer complete in the office
 - Provide customer with contact information (flyer with QR code) for an online appointment with an interviewer telehealth style

- National HIV/AIDS Strategy (NHAS)
- Ending the HIV Epidemic (EHE)
- Integrated Plan
 - CDC's Division of HIV/AIDS Prevention
 - HRSA's HIV/AIDS Bureau
 - Planning and implementation of both HIV prevention and care services

All CDC and HRSA funded jurisdictions must submit an Integrated Plan

EHE Goals

Diagnose all people with HIV as early as possible.

 ${\bf Treat}\,$ people with HIV rapidly and effectively to reach sustained viral suppression.





Prevent new HIV transmissions by using proven interventions, including pre-exposure prophylaxis (PrEP) and syringe services programs (SSPs).

Respond quickly to potential HIV outbreaks to get needed prevention and treatment services to people who need them.






Integrated Planning is Designed To:

- Assess resources and service delivery gaps and needs across HIV prevention and care systems to ensure the allocation of resources based on data
- Address requirements for planning, community engagement and coordination
- Improve health outcomes along the HIV care continuum by using data to prioritize populations
- Promote a status neutral approach
- Advance health equity and racial justice and equitable delivery of services and engage people with lived experience in service delivery system design and implementation
