Bundle Services vs Non-bundled Services

Bundled Services

- All services must be delivered at provider site
- All leveraged funding must be verified by NOA and approved budget
- Deliver services according to PHS guidelines and service standards
- Cost reimbursement
- Approved budgets, work plans and scopes of work

Non-Bundled Services

- Deliver services according to PHS guidelines and service standards
- Cost reimbursement
- Approved budgets, work plans and scopes of work


